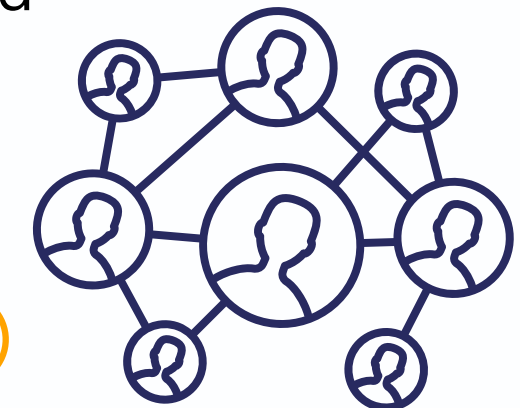


Events, Training and Networking

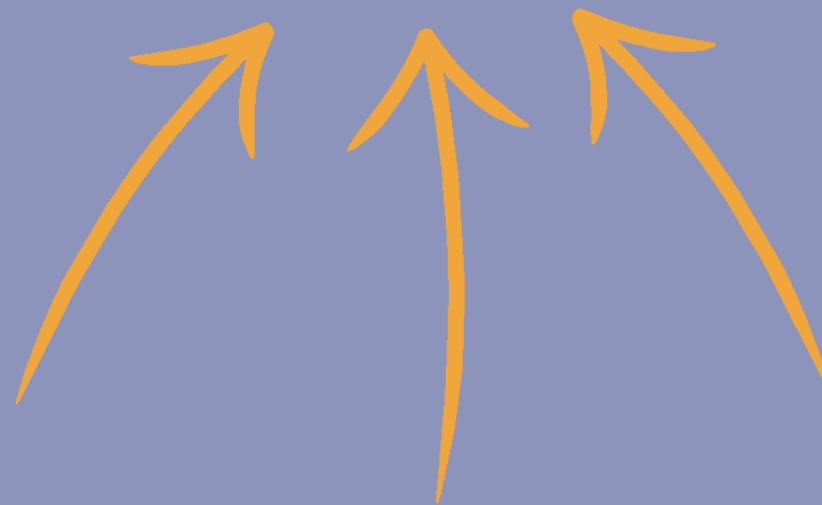

Members also have access to a free spend analysis tool for their local spend data.



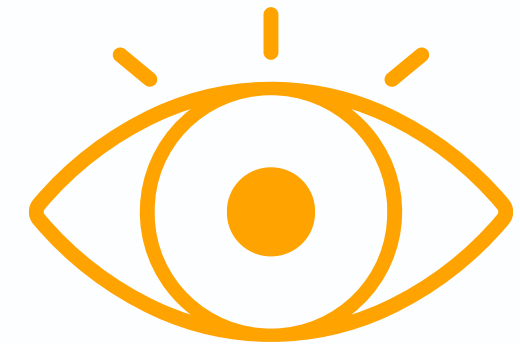
Responsible Procurement

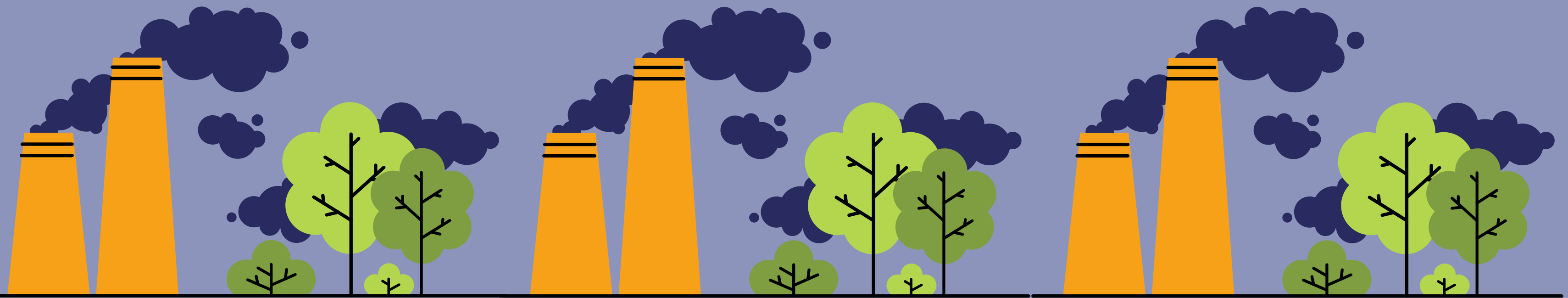

Scope 3 Emissions Calculations

LUPC Offers its full members **Scope 3 reports** based on the **Higher Education Supply Chain Emissions Tool**.

This allows members to look into both the reduction of carbon emissions and carbon offsetting measures. The Scope 3 report shows data at a supplier level, so there is full visibility of where the greatest reductions are available, especially if this is combined with accounts data to look at emissions at a department level.
