


## Total spend

As we look forward to our 50th anniversary next year, more than ever our ability to work together, by pooling our collective knowledge, expertise and buying power, becomes essential in these challenging times. The business case for collaboration in the procurement of goods and services grows ever stronger and LUPC Members are in the very best position to benefit from it.

This year we warmly welcomed the National Physical Laboratory, the Defence Science and Technology Laboratory, Historic Royal Palaces, the Harris Federation and the City of London Corporation's educational institutions including the Guildhall School of Music and Drama as new Members of the consortium.

Another busy contracting year has seen our team of experienced professionals leading projects in desktop and notebook PCs (now worth £440m nationally over four years), insurance, a new national agreement for legal services and a brand new agreement for catering consultancy, heralding our forthcoming framework agreement for outsourced catering services scheduled for 2018.

We've also participated in wider contracting for higher education with colleagues in our sister HE consortia, helping to deliver national deals in books and eBooks, antibodies and sera, training and executive recruitment services.

Many of you will know that buying our goods and services responsibly is a key strategic aim for our consortium, reflecting as it does the values of our Members, suppliers, staff and students alike. Thankfully, our new Responsible Procurement Advisory Group, comprised of procurement professionals, sustainability managers, academics and students drawn from the membership is there to drive our programme forward. We've included a summary of the group's first annual report in this document as a useful update for our Member and supplier community.

Now this year have a new group of people, a group that drives us to achieve our strategic aim of leading the wider public sector in the field of Responsible Procurement. We've produced guidance for public procurers on protecting human rights in the supply chain, we've begun learning from the experience of due diligence in our highest risk categories and we've become the first education sector body anywhere in the world to be assessed against the new international guidance standard for sustainable procurement.

# New Agreements

**2016/17 has been a busy period for LUPC with significant activity across our range of agreement categories.**

Following the reappointment of brokers AJG the previous year, the 16-Lot competitive tender process for underwriting services commenced in late 2016 and was awarded the following summer across a number of specialist Higher Education providers including ZM, RSA and Novae.

Several risk-themed seminars were organised on behalf of the 43 members of the Insurance Group and the majority also have an active role within the benchmarking club. Another LUPC-led project familiar to many users, the LUPC Gases Agreement, was awarded across 12 separate lots including gas monitoring equipment for the first time.

The consortium was involved in a number of collaborative tendering projects that also commenced in late 2016 including the national agreement for Electronic Components, the Software License Resellers Agreement (SLRA) and the newly re-structured Server, Storage and Solutions National Agreement ('SSSNA'). LUPC Members can also access the new APUC-led Student Information Management Systems (SIMS) framework. The Lasers agreement was also re-tendered in 2016.

Two brand new framework agreements under STEMED and LABS have been awarded this year; 3D Printers, 3D Scanners and Associated consumables was initiated in March 2017. Antibodies and Sera (and other related matrices) also began in July 2017.

The catering consultancy services framework went live in September 2017. This is a new national framework which is open to all Members of the university purchasing consortia nationally. This national framework agreement covers a wide range of catering consultancy services applicable to outsourced catering services and/or in-house catering services. There are 10 suppliers on the framework and call off is either directly awarded to the number ranked supplier, or further competition.

A National Legal Services agreement was also launched in May 2017, a launch event in support of this took place in November. The event was attended by over 100 delegates throughout the day. Following the event, feedback proved that the event encouraged the majority of attendees to actively use the framework. The agreement was a result of a collaborative exercise between all English and Welsh higher education purchasing consortia.

# New Agreements (contd)

Perhaps one of LUPC's most significant lead projects, the National Desktop and Notebook Agreement ('NDNA'), was tendered throughout 2017 and commenced in September. Several participants attended the Conference on University Purchasing ('COUP') held that month at Swansea University to talk directly to institutions about the benefits of using the framework. LUPC hopes to organise an event in early 2018 to assist in further promotion of the agreement.

## A look to 2018...

The Networking Supply & Services Agreement is expected to go to market in early 2018 and the Electrical Materials framework was likewise re-tendered during 2017 for an early 2018 commencement, looking to bring additional savings and benefits for Members in areas such as LED lighting. A Debt Collection Services agreement will be going live in February 2018.

It is also likely that the framework agreement for Occupational Health Services is likely to be extended/re-tendered during the course of 2018.

The Temporary Staff framework agreement will be extended to September 2018, and LUPC plans to join the national framework agreement for the next iteration.

As well as all of this, LUPC is currently tendering a new framework agreement for Catering Outsourced Services which is scheduled to go live in March 2018. The framework agreement will be divided into two Lots; Lot 1: Outsourced Contract Catering Services (National) and Lot 2: Office, Corporate and Event Catering (Greater London). Call off for both lots will be via further competition. A launch event for both this framework and the catering consultancy services framework already awarded will be held towards the end of April 2018 and will be a free event for all members of university purchasing consortia nationally to attend.

# Responsible Procurement

As Chair of LUPC's Responsible Procurement Advisory Group, that brings together procurement professionals with sustainability managers and students drawn from the membership, I am pleased to present our first Annual Report.

The purpose of our group is primarily to formulate and recommend LUPC's Responsible Procurement Policy and Strategy, along with projects and actions by LUPC to deliver the strategy, ensuring that the programme has vigour and broadly reflects the values of LUPC's membership. LUPC has made strong progress across this programme during the year.

This year, LUPC adopted the new ISO 20400 Guidance Standard on Sustainable Procurement, which includes specific guidance on social responsibility in supply chains. Action Sustainability assessed us against the new standard, scoring us a creditable 3.71 out of 5. Lead consultant James Cadman said that "LUPC has clearly and unambiguously adopted Responsible Procurement as its methodology for procuring goods and services. LUPC's culture and approach, not least in relation to social issues and matters around modern slavery, are forward thinking, fully embrace best practice and set a good example to emulate." Our group aims to drive LUPC to improve its score over the coming year.

In late 2016, LUPC's Board committed funds for a Modern Slavery Project designed to explore ways of tackling human rights abuses in its supply chains. This has been developed in partnership with academics at the Business, Human Rights and the Environment Research Group at the University of Greenwich, led by Dr Olga Martin-Ortega, who was elected to the LUPC Board in 2015.

Our project team can provide advice and support to LUPC staff and the wider Membership on promoting respect for human rights in the supply chain and working with the supplier base to mitigate the risks of abuses.

## Our Modern Slavery Project

The project has four principal workstreams:

1. The first output was our professional guidance, published in collaboration with the University of Greenwich, APUC and CIPS. Entitled Protecting Human Rights in the Supply Chain, a Guide for Public Procurement Practitioners, it is now available for free download from LUPC's website. The Guide will be followed by a series of free eLearning topics before the New Year.
2. During 2017 we have aimed to address the risk of human rights abuses through a pilot supply chain due diligence exercise for laboratory gloves, now well under way. Our intention is to establish whether alleged human rights abuses have yet been resolved by the suppliers and to advise our Members accordingly. It's also to gain first-hand experience of due diligence such that we can learn from the process and use the knowledge we acquire to inform our long-term planning for this activity.
3. Our third task under the Project aims to address a UK-based risk by initiating a series of supplier audits with our cleaning and security services contractors. Our framework agreements include clauses requiring our suppliers to demonstrate their ongoing commitment to ensuring that they take steps on our behalf to guard against human trafficking in their supply chains throughout the term of the agreement. This involves identifying the risks and implementing action plans to address them jointly with our contractors.
4. We recognise that our knowledge of the supplier base and its capability to supply responsibly requires a systematic method of gathering, processing and retrieving data about our supplier base. We are now building Equiano, our new Responsible Procurement database. The database is expected to be commissioned by the New Year.

# Responsible Procurement (contd)

In March, the UK Parliament's joint committee on human rights published its report on human rights and business. LUPC made five recommendations that, if implemented, would enable the Government to fulfil its obligations under the UN Guiding Principles on Business and Human Rights.

LUPC continues to be a Member of the International Learning Lab on Public Procurement and Human Rights. In April, LUPC's Director contributed to evidence submitted to an inquiry into establishing a Modern Slavery Act in Australia.

LUPC renewed its affiliation to Electronics Watch this year, the collaborative organisation monitoring global electronics supply chains. We included supplier due diligence and monitoring clauses in the latest iteration of HE's National Desktop and Notebook Agreement, a £440m national supply agreement managed by LUPC, giving us contractual rights to enter into dialogue with suppliers and collaborate with them to establish due diligence and mitigation strategies to address human rights risks.

In May, LUPC's annual conference, staged in partnership with Southern Universities Purchasing Consortium, included a major panel session for 80 attendees on the Modern Slavery Act. In June, in collaboration with the University of Westminster and Electronics Watch, LUPC staged a screening

of Complicit for Members and partners, a documentary by Heather White and Lynn Zhang. The film follows a group of workers in a Chinese electronics factory struck down by illnesses following prolonged exposure to toxic chemicals used in the manufacturing process.

I firmly believe that LUPC has demonstrated its commitment to Responsible Procurement and to delivering its ambitious strategy. In particular, LUPC will continue to work with partners and suppliers to gain first-hand experience of supply chain due diligence and of mitigating the risks to human rights.

As LUPC acquires knowledge and develops capability in this activity, the intention is to codify and communicate or the wider benefit of those practices that are found to be the most successful.

## LUPC has this year been able to report on early success with Electronics Watch

In October 2015, Electronics Watch (EW) and its affiliates had learned about an NGO report on Wistron, a large server manufacturer in China, alleging serious labour rights violations including forced labour.

Students were reportedly forced to perform an internship unrelated to their vocational aspirations as a requirement for graduation. In addition, the student workers reported working hours as much as 10-12 hours a day, 6 days a week and 48 hours of overtime a month, all in excess of local legal limits.

EW responded by evaluating the evidence for the allegations and identifying, in specific terms, the risk of violations of Chinese law, the International Labour Organisation conventions, and the EW Code of Labour Standards. EW also recommended specific action for affiliates to take with their suppliers.

LUPC and other HE purchasing consortia that purchase these servers contacted their account management representatives at each supplier, spurring the major brands into action. All brands are committed to temporarily halting student labour at the factory and to ensuring compliance with the legal limits on student labour.

In December 2016, EW conducted follow-up off-site worker interviews and found no evidence of student labour.
